About Hong Kong Information Technology Federation (HKITF)

The Hong Kong Information Technology Federation ("HKITF") was founded in 1980 as a not-for-profit, non-political trade association to provide a forum in which the IT-related business in Hong Kong can work together for the benefit of the industry and to maintain a high level of business practice amongst the members. Currently, HKITF has over 300 members.

HKITF acts as the bridge for international IT companies looking for local partners and works with trade commissions to host trade promotion events. It supports and sponsors various IT sectors to develop focus groups; promotes local IT business through various activities; and also helps keeping members abreast of local IT developments and business opportunities.

In the public sector, HKITF works closely with the government to promote the development of the local IT industry. HKITF represents the industry on the Committee on Economic Development and Economic Cooperation with the Mainland of Commission on Strategic Development, Committee on Management and Supervisory Training under Vocational Training Council, Industry Training Advisory Committee under Employment and Manpower Bureau, Digital 21 Strategy Advisory Committee, Transport Advisory Committee, Special Task Force on Information Technology (OGCIO), Task Force on Facilitating the Adoption of Wireless and Mobile Services and Technology, TV Programme Advisory Committee of Radio Television HK, Electronic & Communication Committee of Occupational Safety & Health Council and many other government committees. There are 4 categories of members as follows:

i) Full Member: HK\$2,500 (per year)

Organisations the predominant part of whose activities are supplying information technology products or services. Only corporate members will have the voting right.

ii) Overseas Member: HK\$2,000 (per year)

Organisations or companies incorporated outside of Hong Kong that express an appropriate interest in the information technology industry in Hong Kong.

iii) Associate Member: HK\$1,500 (per year)

Organisations that have an interest in developing the information technology industry and, although not being primarily in the industry itself, have some part of their current activities supplying information technology products or services.

iv) Affiliate Member: HK\$1,000 (per year)

Individuals who express an appropriate interest in the information technology industry.

Subscriptions:

The annual subscription fee is HK\$2,500 for Full Members, HK\$2,000 for Overseas Members and HK\$1,500 for Associate Members and is payable upon acceptance of the application by HKITF. Individuals may apply for Affiliate only and the annual subscription fee is HK\$1,000.

HKITF member (only Full Member) is authorized to use HKITF logo in his/her business card.

The principal objects of the Federation are:

- To protect, promote and advance the Information Technology industry in Hong Kong.
- To promote a high ethical standard in the conduct of business within the Industry and to develop the confidence and respect of the public.
- To act as a central advisory consultative and coordinating body for the Industry.
- To represent the Industry on all matters concerning it in discussions with the Hong Kong Government.
- To create a greater public awareness of the benefits and essential role of the Industry and of the corporations and persons operating within it.
- To collect, compile and distribute amongst the members of the Federation information and data that will be of assistance in carrying out the objects of the Federation.
